### WHAT DOES A GAL DO?

-  Department of Social Services files petition with local district court on behalf of child.
-  Judge appoints a Guardian ad Litem (GAL) and program pairs child with GAL advocate volunteer and attorney.
-  GAL meets child, gets to know them and visits with them at least once a month.
-  GAL's goal is to advocate until child achieves permanency (returned home, placed with family, or adopted).

-  GAL provides advocacy by representing child's best interests in court.
-  GAL communicates with everyone in child's life (parents, foster parents, family, doctors, social workers, teachers, etc.).

A HOME FOR CHILDREN AWAITING FOSTER PLACEMENT

## HOME

Currently when children enter foster care and no placement can be found they have to stay at the DSS office. This results in them sleeping on a cot on the floor, showering at a separate location and eating fast food daily. This leads to an additional trauma.

Meg's Place wants to lessen that trauma by providing them a loving, child friendly environment to eat, shower and sleep if needed. The home will be stocked with the items needed such as clothes, toys and hygiene products, for when placement is found.

## OTHER SERVICES

The home will be set up with indoor and outdoor visitation areas so parents can visit their children in a comfortable, supervised, and child friendly environment.

Meg's Place will also offer trainings for Parents, Foster Parents, and children aging out of foster care.




