## Introduction

Christian Perspective Representatives Inc. is a cooperative group of volunteers from churches who stand in unison for Biblical values and Constitutional rights, support and affirm human dignity, and value all people.

C.P.R., Inc. began in 2021 as a nonpartisan group to circumvent the loss of freedoms of our children, parents, and employees in public schools and institutions throughout our state and nation. Since we believe there is a potential for topics such as sexuality, gender identity, and extreme theories to be taught to our children in harmful and potentially damaging ways, we want to be part of the solution.

C.P.R., Inc. operates strictly on a volunteer basis. No one involved with C.P.R. receives any type of compensation.

C.P.R. does not endorse or oppose any candidates for public office or any political party. This questionnaire is being distributed electronically through our website, mainstream and social media, supporting churches, and other means. We have produced a questionnaire for: (1) Board of Education, (2) Board of Commissioners, (3) District Attorney, and (4) Sheriff races.

The purpose of our questionnaire is to inform and educate voters of each candidate's position on a variety of general topics that are relevant to C.P.R.'s mission. As a faith-based organization, the questionnaire was designed to be distributed through Churches where the topics of the questions are of the utmost interest to a Christian voter.

## Questionnaire Information

The responses gathered from the questionnaire were provided directly by the candidates themselves. C.P.R. utilized a multiple-choice format for the questions, offering candidates the option to expand on their responses within a 950-character limit. Upholding the questionnaire's integrity, candidate answers are presented verbatim, without any modifications for grammar or spelling. Each candidate was contacted in an attempt to encourage their participation using the contact information obtained from the North Carolina State Board of Elections website.

If a candidate did not submit a response, the publication will indicate "Did Not Respond." In cases where a candidate replied via email, telephone, etc., but opted not to participate, the publication will note "Refused to Respond." The party affiliation of each candidate is listed beside their name: (D) for Democrat, (L) for Libertarian, (R) for Republican, (U) for Unaffiliated.

# **Board of Education Candidate Responses**

## **Glenwood District**

### **Terry Frank (R)**

- 1) Do you believe life begins at conception and deserves legal protection?

## **Marion District**

### **Marvin F. Greer (R)**

- 1) Do you believe life begins at conception and deserves legal protection?

Answer: Yes. I wholeheartedly believe life begins at conception based on the Bible and based on science. Jeremiah 1:5 says, "Before I formed thee in the belly I knew thee". The Bible mentions in Job 3:3 "... the night in which it was said, There is a man child conceived." Here the word CHILD is connected to the moment of conception. Science defines a human as 46 chromosomes which come together at fertilization, 23 from the male and 23 from the female. Therefore, life has begun and should be protected and loved as much as any other person.

## **Angela Allen-Helms (R)**

- 1) Do you believe life begins at conception and deserves legal protection?

This life, regardless of size, location, level of development or dependency on others, has inherent worth from the earliest stages of development. Upholding this principle affirms a consistent commitment to human dignity and equality under the law. However, there are situations when impossible, heart wrenching decisions must be made by parents to end the pregnancy, due to the life or health of the mother. - 2) Who has the ultimate responsibility for the education of children in public schools?  
Answer: Parents. Parents bear the ultimate responsibility for their children's education. They are the primary caregivers and ultimate moral guides in their child's life. Public schools exist to support and partner with families, not replace them. However, the education of our children is best achieved when parents, teachers, faculty and administration work together to achieve educational excellence for each and every child in the system. This is accomplished when schools provide instruction that complements

parents' values, expectations and involvement. As parents, we are responsible for being interested and engaged in our children's education while supporting the public school institution in every way possible.

- 3) Should sexually explicit books be removed from school libraries and classrooms?

Answer: Yes. I am an avid reader. I believe that books open a world of learning and adventure for our children. Through reading, kids can explore a vast world beyond our own lives, allowing readers to explore new ideas, cultures and experiences while deepening empathy and broadening imaginations. I do believe that sexually explicit books should be removed from public school libraries and classrooms. With today's technology, there are so many avenues for easily accessing books of interest, outside of our classrooms and libraries. These are great options for parents who want their children to have unlimited access to any and every book. Our public school libraries should prioritize age-appropriate educational materials. Thus, helping to protect children's development and ensuring that they are not exposed to objectionable material they are not emotionally or psychologically ready to handle.

- 4) Do you support any Diversity, Equity & Inclusion (DEI) programs?

Answer: Refuse to answer. I believe that all men are created equal with certain inalienable rights. I would venture to say that I have one of the most diverse families around, having both children with varying special needs of Asian descent. However, I believe that any formal DEI program, policy or statement in public schools only serves to replace equal treatment and merit-based standards with ideological frameworks that can inadvertently divide students, politicize the classrooms and distract from the core mission of optimal academic achievement and shared civic education.

- 5) Should all classroom materials and lesson plans be publicly available to parents?

Answer: Yes. Any parent should be able to access and review their child's educational materials at any time. This ensures transparency, builds trust and allow parents to stay fully informed and engaged in their children's education.

- 6) Should biological males be allowed to compete in girls' sports or use girls' locker rooms?

Answer: No. As a medical professional and mom, I cannot support having males present in girls' locker rooms. I would not want this for my own children. I do believe that males physically have an advantage in competitive sports, based on male genetic code biologically. # District Attorney Candidate Responses

## Tedd Bell (R)

- 1) Have you ever been convicted of a felony or penalized for sexual misconduct?

Answer: No.

- 2) Do you believe life begins at conception and deserves legal protection?

Answer: Yes.

- 3) Should crimes involving child abuse, sexual exploitation, or trafficking be prosecuted to the fullest extent of the law?

Answer: Yes. One area my office particularly focuses on is child sexual predators, and we have sent these monsters to prison for the longest sentences in the history of our District - numerous sentences of over 100 years in prison, up to 175 years in prison.

- 4) Should repeat offenders of crimes against children face enhanced charges or sentencing when allowed by law?

Answer: Yes. We use every tool available to protect children from these predators, and do everything we can to get the toughest sentences we can. I wholeheartedly support repeat-offender enhancements for these predators.

- 5) Should violent crimes be prosecuted to the fullest extent of the law whenever legally possible?

Answer: Yes. Our primary responsibility is the safety of the community, and violent crime directly attacks that safety and security. We take violent crime very seriously and do everything we can to maximize the consequences for the defendant while protecting the victims.

- 6) Do you oppose "catch-and-release" policies that quickly return repeat offenders to the community?

Answer: Yes. We are bound by the sentencing laws established by the legislature, but do everything we can within those limitations to hold people accountable and prevent them from coming back through court. For example, we have increased the number of habitual felons sent to prison by 350%. We have also sent 750 people to prison for breaking into our homes. In addition to tough sentences, we work closely with many local organizations to get treatment and services for defendants to try break that cycle of recidivism.

- 7) Should drug trafficking and fentanyl-related crimes be treated as top prosecution priorities?

Answer: Yes. We have sent over 100 drug dealers to prison just in the last four years. We have sent 10 drug dealers to prison for Death by Distribution just last year - the most in the State. We work with many organizations to get treatment for the drug users, but come down like a hammer on the drug dealers.

- 8) Should victims' rights, especially those of children, be prioritized in charging decisions, plea agreements, and sentencing recommendations?

Answer: Yes. It is a priority in our office to give victims input into the handling and disposition of their case. And while our number one priority has always been the safety and security of the community, victims' requests are given strong consideration in case decisions. We have always gone beyond the requirements of the state's Victim's Rights Act.

- 9) Should the District Attorney publicly report prosecution outcomes to ensure transparency and accountability?

Answer: Yes. The District Attorney's office has recently converted to a paperless system where all court files are computerized and available to the public, and the outcome in every case is now publically available online.

- 10) Do you support faith-based or restorative justice programs for non-violent offenders who voluntarily participate?

Answer: Support. I have worked with several faith-based programs, such as Freedom Life, for years in seeking effective long-term outcomes to our criminal prosecutions and in working to get defendants the treatment and services they need as we fight the cycle of recidivism.

As Sheriff, I will remain steadfast in holding predators accountable and ensuring that justice is carried out with both strength and moral clarity.
